


Essential facts about the Covid-19 Injections/“Vaccinations”

1. Are the new COVID-19 „vaccines“ really vaccines?

According to the classic definition, a vaccine protects against a certain infectious disease and makes the vaccinated person immune. Immunity is not guaranteed with the Covid injections called “vaccines”. While with the classic vaccinations a killed or weakened virus is injected in order to stimulate the immune system to produce antibodies, the Covid shot uses experimental – emergency use authorization only - mRNA or vector based gene therapy. This is a completely new technology that has never been applied to humans before. Animal trials were not completed. What they all have in common is that they smuggle in foreign, artificial viral genetic codes material (NOT actual virus) into human cells in order to turn them into “factories” of proteins like the spike proteins on the surface of the real virus. These spike proteins should then be identified as foreign by the immune system and trigger the formation of antibodies to the spike proteins. 

2. Are the "new vaccines" dangerous?

Usually a vaccine takes 8-10 years to develop. The Covid injections were approved for emergency use only after just 9 months of development before the test phases were completed.



The chart above illustrates the number of suspected adverse reactions to COVID-19 vaccines, i.e. Janssen (AD26.CO2.S), Moderna (CX-024414), Pfizer-Biontech (BNT162b2) and Astrazeneca (CHADOX1 NCOV-19)) by seriousness reported to the European Medicines Agency (EMA) up to June 5, 2021. The number of people who are vaccinated is constantly growing. On June 5, 2021, Our World in Data (7) reported 250 million people who have received at least one dose of COVID-19 vaccine.

By that day, Astrazeneca showed with 142,814 cases out of a total of 264,549 reported cases the highest number of serious cases, both in absolute terms and in percentage (54%). In terms of deaths in Europe related to COVID-19 vaccine, Pfizer-Biontech is on top with 4,233 fatal cases. (8)



The Urgent Open Letter from Doctors and Scientists to the European Medicines Agency (EMA) regarding Covid-19 Vaccine Safety states (9):

[...] We note that a wide range of side effects is being reported following vaccination of previously healthy younger individuals with the gene-based COVID-19 vaccines. Moreover, there have been numerous media reports from around the world of care homes being struck by COVID-19 within days of vaccination of residents. 3. Why Covid injections are NOT necessary?

Natural immunity to coronavirus rests on two pillars:

Antibodies and specialized cells of the immune system, the so-called helper lymphocytes and killer lymphocytes. When a virus enters the body and causes disease, the immune system responds by mobilizing this "defense army". It seems that our body combats coronaviruses "primarily with cytotoxic T cells and killer lymphocytes, which cannot be stimulated by a [so-called COVID19-] vaccination."(12)

That means we have an immunological process that actually gives stronger and longerlasting protection than the Covid injection. In addition, the Covid injection does not guarantee protection (13). Recent evidence, Dr Peter McCulloch on Bitchute interview, shows us that people who have been injected can continue to be infected, contract COVID and even transmit the virus (14). According to the International Journal of Vaccine Theory, Practice, and Research" a vaccine at the stage of a Phase III clinical trial has a 2% chance of success."(15)

Consequence: The logical answer can only be to avoid endangering health through a Covid injection that turns healthy people into chronically ill patients and in the worst case leads to life-threatening side effects or death. Children who are statistically proven neither to contribute to the infection nor are they at risk from the virus with a 99.997% survival rate (16), nor adults who are asymptomatic, DO NOT NEED an experimental, emergency use only approved gene-based Covid-19 injection. Ivermectin, Hydroxychloroquin, Vitamins and other treatments have reduced death rates by over 70% in several USA states and other countries. (17)



4. What is the scientific basis for the pandemic situation?

5. Why is nobody talking about natural herd immunity anymore?


Herd immunity is achieved when many people (usually around 70% of the population) have become immune to a particular disease that any chain of infection quickly breaks off and the disease cannot spread any further.

Extract from the Great Barington Declaration signed by many thousands of doctors worldwide:

"We know that old and frail people are more than a thousand times more likely to die from COVID-19 than young people. In fact, COVID-19 is less dangerous to children than many other ailments, including influenza. As immunity builds up

in the population, the risk of infection decreases for everyone - including those at risk. We know that all populations eventually reach herd immunity - that is, the point at which the rate of new infections is stable.

Our goal should therefore be to minimize mortality and social harm until we achieve herd immunity. The most empathic approach, which weighs the risks and benefits of achieving herd immunity, is to allow those who have minimal risk of death to live normal lives so that they can build immunity to the virus through natural infection, while those who are most at risk will be better protected. We call this targeted protection." (20)
